



Acknowledgements

- I understand that any decision to hire me is contingent upon the results of my consumer report and/or investigative consumer report and upon successful completion of a drug screen, if required. A job applicant may refuse to undergo drug and alcohol testing. In the event of such refusal, the contingent offer of employment will be withdrawn.
